



MEMORANDUM OF AGREEMENT FOR EDUCATIONAL AND ACADEMIC EXCHANGE COOPERATION

BETWEEN

ALAUDDIN STATE ISLAMIC UNIVERSITY (UIN) **INDONESIA**

AND

MAEJO UNIVERSITY AT CHUMPHON **THAILAND**

Between Faculty of Ushuluddin dan Philosophy, Alauddin State Islamic University (UIN), Makassar - Indonesia and Maejo University at Chumphon (MJU) - Thailand

Faculty of Ushuluddin dan Philosophy, Alauddin State Islamic University (UIN), Makassar - Indonesia and Maejo University at Chumphon (MJU) - Thailand, agree to implement an Educational and Academic Exchange Cooperation in accordance with the principles and guidelines set forth below. The purpose of this agreement is to enhance the educational experiences and the cultural understanding of students and faculty both institutions.

It is agreed that:

- 1. The purpose of each student exchange will be to enable students to take classes but not to study for a degree at the host institution.
- 2. Within the framework of this exchange, "home university" will mean the institution in which a student is formally enrolled as a degree candidate, and "host university" will mean the institution that has agreed to receive students from the home institution for a period of study on a non-degree basis.
- 3. The exchange student program should be commenced in the home or host universities' semester break vacation or during an internship program, once per year and not exceeding three month. The number of exchange students should not exceed five per year from each institution, unless both institutions agree to accept more students.
- 4. Participants in the program initially will be draw from Faculty of Ushuluddin dan Philosophy, Alauddin State Islamic University (UIN), Makassar and Maejo University at Chumphon, at the discretion of the two institutions. By addendum, the exchange can be extended to include other colleges and departments, as long as the principle indicated in 3 is uphold.
- 5. Student participants will be screened for eligibility for admission by the home institution.
- 6. The departments/divisions involved in the exchange at the home university will provide academic counseling to ensure that the students can understand the courses offered by the host institution. The home institution should respect the courses offered by the host institution.
- 7. The exchange student should submit the final report to the host institution. The host institution will evaluate the students' performances with the eveluation form provided by the home institution.
- 8. Faculty of Ushuluddin dan Philosophy, Alauddin State Islamic University (UIN) and Maejo University at Chumphon will require participating students to register at their home institution and pay all academic fees and tuition to their home institution. Participants will be exempted from paying such fees and tuitior at the host institution.
- 9. The host institution will provide the accommodation for all exchange students, but will not be responsible for other expenses.
- 10. This Agreement shall be effective for five years This Agreement is subject to review, revision, modification or renewal by mutual written agreement. Either party may terminate the Agreement by written notice submitted before the end of June each year. Termination would not affect students already engaged in the Agreement.
